Wellbeing **Economy Seminar**

The Wellbeing Economy, Governance and Public Policy: Creating a Sustainable and Fairer Future

The Centre for Health in All Policies Research Translation (in collaboration with the Department of Premier and Cabinet) hosted Dr Katherine Trebeck for a seminar on the role of government and the public sector in the transition to an economy that puts people and the planet first. The seminar included a keynote presentation by Dr Katherine Trebeck (which focussed on the current climate trajectory and future actions to be taken) and an interactive panel discussion with six panellists (see below) that examined how individual organisations could work towards a more sustainable ideal.

- What is the role of government and public policy decision-making?
- What can government policymakers do to help progress the WE agenda?
- How does the WE agenda connect to and impact the business of government?
